I am part of a National Task Force known as the South Florida Internet Crimes Against Children (ICAC). This task force investigates internet crimes against children, child exploitation, and related cases.

On 12/07/2021, I received National Center of Missing and Exploited Children (NCMEC) Cyber Tip Report #106375240 from the Broward County Sheriff's Office (BSO) South Florida ICAC task force. The Cybertip was reported by the chat application KIK in reference to one of their users who transmitted (11) files that depicted the sexual abuse of prepubescent children.



## NARRATIVE CONTINUATION

On 02/08/2022, I obtained a residential search warrant from Honorable Judge Renatha Francis for the residence located at 10651 Misty Lane, Royal Palm Beach, FL 33411. On 02/10/2022, members of the PBSO Tactical team and Cyber Crimes Unit met at 0600 hours to be briefed and review the pending execution of the search warrant. PBSO's Tactical team executed the search warrant shortly after.

Detective Lopez and I made contact with Dylan Casto outside of his residence, he agreed to speak with us in my unmarked PBSO vehicle. Post Miranda, Casto provided his phone number (407) 579-7313 which is listed on his Gmail account. He denied having a KIK account and requested a lawyer. Upon searching his residence, his Visa card ending in [REDACTED] was located in his bedroom; this credit card is listed on his Google account for billing. The email address account mac.cam104@gmail.com was found on the pink iPhone which was located next to his bed.

Two iPhones, iPad and the desktop computer were seized and entered into PBSO evidence for further forensic examination.

Based on my investigation, the suspect did knowingly possess (1) or more images of sexual performance by a child in violation of Florida State Statute 827.071(5).
