The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the above named Defendant committed the following violation of law.
On February 5, 2021, at approximately 11:24 p.m., a hit-and-run vehicle versus pedestrian style crash occurred within the 600 block of N Dixie Highway, Lake Worth, Palm Beach County, Florida. As a result of this crash, the pedestrian was struck with the front right of the vehicle. As the crash ensued, the pedestrian was propelled to the pavement and the vehicle fled the scene northbound. Prior to the crash, it appears the pedestrian had been crossing Dixie Highway and was occupying the outside northbound lane, not in a crosswalk. Subsequent to the crash events, the driver, Dylan Levin (birth date of 02/15/1992), failed to slow, stop, and render aid to the pedestrian. Levine failed to provide his identifying information prior to fleeing the crash scene. The vehicle was last seen traveling northbound on Dixie Highway. The West Palm Beach Police Department located the vehicle disabled on Olive Avenue and Russlyn Drive, West Palm Beach. Officer Krol of the West Palm Beach Police Department notified the Palm Beach County Sheriff's Office.
On 02/06/2021, at approximately 12:08 a.m., I arrived at the crash scene and viewed the evidence. I saw the pedestrian in the roadway positioned in the outside northbound lane. She was later identified by her Florida driver license as Chrystal Click (Caucasian female, birth date of 07/28/1981). She suffered critical/serious injuries that led to her death. She had multiple blunt force trauma injuries, as a result of the collision. During
the inspection it was evident the pedestrian had been stuck and thrown to the roadway;

thus, the driver would have known of this crash, because of the loud noise caused during the impact and the violent jarring of the vehicle as it traveled into the pedestrian. While on scene, I located several pieces of headlight plastic and white front grille, which had been broken during the crash from the suspect vehicle.

Witnesses Jorge Ortiz and Joseph Yonel stated they were traveling northbound with a white older model Ford F150 single cab on Dixie Highway driving in the outside lane at 6th Avenue. They said they heard a loud bang and the pickup truck began to accelerate and did not stop. Ortiz said he was going to pursue the truck but remained on scene and called 911. Ortiz described the truck as an older model F150 single cab with a dolphin sticker in the back window, a double tube rear bumper and wide tires that stuck out from the side of the truck. Ortiz also stated just prior to the collision at the intersection of Lake Avenue and Dixie Highway, he saw the driver and described him as a skinny white male with a light blue shirt on. Yonel described the truck as an older model Ford with a dolphin sticker in the back window and big tires.

The suspect vehicle was identified as a 1995, white, Ford F150 bearing Florida tag "NSFP25". The VIN is 1FTDF15R5SLA84010. The vehicle came back registered to Dylan Levin (birth date of 02/15/1992) of 1215 Clydesdale Drive, Loxahatchee, Florida 33470. I arrived at the vehicle's location, Olive Avenue and Russlyn Drive, at approximately 2:30 a.m. and identified damages to the right front of the vehicle to include: a bent hood from impact with the pedestrian, body fluid and marks on the front of the vehicle in the damaged areas, a broken passenger headlight, and body fluid/tissue from the pedestrian on the undercarriage. I matched the recovered headlight and grille pieces recovered from the crash scene to the vehicle and it matched perfectly. The F150 also had a sticker of a tarpon in the back window, a double tube rear bumper and wide tires, as described by the witness. The damage, missing parts and physical description of the vehicle matched witness statement and collision dynamics.

Further witness testimony from Adam Kaye revealed Levine left Rum Shak bar in Lake Worth Beach as the only occupant of his Ford F150 and Kaye attempted to follow Levin to stop him from driving, because of his intoxication. Levin was able to elude Kaye and

Kaye returned to the Rum Shak bar.

Surveillance video confirmed Kaye's description of the events prior to the collision. Surveillance video also confirmed Ortiz's testimony of being next to Levin at Lake Avenue and Dixie Highway and his path and time of travel prior to and after the collision. Prior to the collision there is no apparent damage to Levin's vehicle and after the collision the passenger side head light is not functional on the video.

This investigator further concludes that there is sufficient probable cause to support the fact that Dylan Levine violated the following Florida State Statutes:
