Defendant also demands a jury trial pursuant to the Florida Constitution and Fla. R. Crim. P. 3.251.

Defendant hereby enters a plea of not guilty to the charges in the above-styled case.

Waiver of Defendant's Appearance At Arraignment and All Pre-Trial Conferences

Defendant, pursuant to Rules 3.180(a)(3) and 3.220(p)(1), Florida Rules of Criminal Procedure, hereby files this written waiver of appearance at the arraignment and all pre-trial conferences. Rule 3.180(a)(3), Florida Rules of Criminal Procedure, states that “[i]n all prosecutions for crime the defendant shall be present . . . unless waived by the defendant in writing.” Rule 3.220(p)(1), Florida Rules of Criminal Procedure, permits a trial court to hold one or more pre-trial conferences and provides that “[t]he defendant shall be present unless the defendant waives this in writing.”

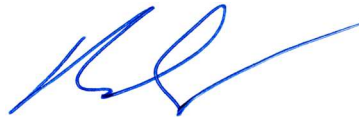
