The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 07/23/2021, at approximately 0324 hours, the affiant observed a silver Ford pickup truck, bearing Florida tag IB93TQ (VIN:1FTEW1E54JFB09221), traveling northbound on Dale Mabry Hw at a high rate of speed. The silver Ford pickup truck was measured traveling 84 MPH in a posted 55 MPH zone via the front antenna of the affiant's HCSO issued BEE III Radar (SN:BEE932000307). The affiant conducted a traffic stop on the vehicle and made contact with the driver/defendant. The affiant detected the distinct odor of an alcoholic beverage emanating from the defendant's person, observed his eyes to be red/bloodshot and watery, him to fumble for request documents, and his balance to be unsteady. The affiant requested the defendant to perform Standard Field Sobriety Exercises (SFSEs), which the defendant agreed to do. During the SFSEs, the defendant exhibited multiple signs of impairment and was subsequently arrested for DUI. The defendant was transported to CBT, where he refused to provide lawful samples of his breath after Implied Consent was read and understood. The defendant was positively identified via his valid Florida driver's license.
