The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 01/31/2020 at 0235 hours I conducted a traffic stop on a silver 2013 Hyundai Sonata sedan, Indiana tag LE5401 after I paced the vehicle at 75 MPH in a 55 MPH zone, north bound on I-275 from Howard Av N to I-4. Upon contact with the driver of the vehicle, defendant Edward Dechow, I observed that he had bloodshot glassy eyes and then as I explained to him why I had stopped him I detected a distinct odor of an alcoholic beverage. The defendant then admitted to drinking in "SoHo". The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed him under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0258 hours. I then transported the defendant to the HCSO/CBT Facility where he refused to submit to a breath test. Implied Consent was read at 0332 hours. I identified the defendant with a valid Indiana DL. He was the only one in the vehicle.
