 On the 25 day of September, 2020 at 22:55 (Specifically include facts constituting cause for arrest.)

On Friday September 25, 2020 at approximately 10:05PM I conducted a traffic stop on a 2012 gray Honda Accord bearing FL/Tag: AKGD78 for a tag light violation; in the 400-block of Northlake Blvd, North Palm Beach, FL 33408.

During my investigation, I made contact with the driver of the vehicle Edward John Ryba W/M 09/29/1963 who presented me with a Florida Identification card. A records check of Ryba revealed he was suspended and marked Habitual Traffic Offender as of 05/15/2017. Ryba stated he knew he was suspended in the past but "was under the impression" it was no longer suspended. Ryba's vehicle was inventoried by Police Officer Wright and towed off scene by All Time Towing.

Ryba was then placed in handcuffs which were double locked and checked for equal spacing and tightness. He was then transported to the North Palm Beach Police Department for processing and later to county jail without incident.

Ryba was issued a warning for a tag light violation per F.S.S 316.221(2) Citation#:10356. Ryba was also issued a citation for Driving While License Revoked (Habitual) per F.S.S 322.34(5) citation#: ADZ24NE.

Edward John Ryba did knowingly drive a motor vehicle upon a highway of the State of Florida, while his driver license was revoked pursuant to Florida Statute 322.264 (habitual offender) and Edward John Ryba had a prior forcible felony conviction as defined in s. 776.08 and/or his driver license or driving privilege was canceled, suspended, or revoked for reasons other than those listed in s. 322.34(10) (a)1-6, contrary to Florida Statute 322.34(5).

At the time of the arrest Ryba was wearing a black shirt, khaki pants and brown shoes. No further information.
