I noticed this vehicle without a tag light at night, therefore in violation of F.S.S. 316.221(2).</p> <p>I then activated my lights and sirens in my marked police vehicle, and the Ford mustang came to a stop at approximately 4000 N Federal Hwy, just North of Spanish River Blvd, in a left turn lane. I then immediately made contact with the driver and sole occupant of the vehicle, white male Edward Schifter, identified by his FL DL. Upon approaching the vehicle, Schifter was already placing his hands in sight. Upon first speaking with Schifter, it appeared that he was very nervous, and he later said he was. I advised him that the reason I stopped him was because his tag light was out. I then asked him for his driver's license, vehicle registration, and vehicle insurance. While waiting for Schifter to provide me with the documents, I was smelling an overwhelming smell of fresh marijuana coming from the vehicle. Sgt Daly appeared as a backup officer, and also stated the vehicle had a strong odor of fresh marijuana coming from inside. He advised the vehicle is registered to him.</p> <p>As I was concluding the traffic stop, I then asked Schifter if he had any hemp inside the vehicle. He stated "yes." I then wanted to clarify, so I asked him if there was any medical marijuana in the vehicle, and at first, he said he did not know, but then later said he does not think it is medical. I then told him that I smelled a very strong odor coming from the vehicle, and he then replied, "It is there." I then asked him where it was, and he pointed to the center console and said, "right in there." He then said that we could have it, and he does not want it. Due to the plain smell and Schifter's admission of it being inside his center console, I then asked Schifter to step outside of the vehicle while I check the center console. Schifter then stepped out willingly and Sgt Caruso informed Schifter that he was going to just pat him down for our safety while he is outside of the vehicle. 

<p>center console. I immediately located a small clear baggie with an unknown white ball substance inside of the center console. Based on my training and experience, I suspected this clear baggie with unknown white ball substance to be cocaine. At this point, I informed Sgt Caruso and Ofc Walker that Schifter is being detained. I also informed Schifter of this, and placed handcuffs on him, checked for tightness and proper fit. Sgt Caruso then continued checking Schifter's pockets for any weapons, and while removing Schifter's credit card and keys from his front right pocket, a yellow spoon fell out of the pocket. The yellow spoon had an unknown white residue on it.</p> <p>Inside the center console, I also located two additional clear baggies with unknown white substance inside each. I also found a clear baggie with an unknown green leafy substance that I suspected was marijuana, which explained the strong smell of marijuana emanating from the vehicle. I then continued to search the entire vehicle and did not locate anything additional.</p> <p>Ofc Careccia then responded to the scene with a department approved QuickCheck cocaine test kit. The testing one of the clear baggies with unknown white powdery substance was captured on my MVR body camera, and a clean sterile Q-Tip was used to deposit the substance into the cocaine test kit. The kit turned blue giving a positive indication for cocaine.</p> <p>I then informed Schifter that he was under arrest for possession of cocaine. I read Schifter his Constitutional Warnings on a preprinted card issued by BRPD, and he advised he understood his Constitutional Warnings. Upon asking Schifter if he knew if there was any fentanyl in the cocaine, he advised he did not know, and the cocaine was not his. I then collected the three clear baggies with unknown white substance, the clear baggie with green leafy substance, the yellow spoon with white residue, and the orange and white pill bottle with joint residue into an evidence bag.</p> <p>I then transported Schifter to BRPD booking, where Ofc Careccia stoodby with him while I then went to field test the other two clear baggies with unknown white substance that were not yet tested on scene. The first clear baggie that was field tested positive on scene weighed 1.6g in baggie. The second clear baggie with unknown white substance weighed at 1.8g in baggie. This baggie was field tested, and the kit turned blue giving a positive indication for cocaine. The third clear baggie with unknown white substance weighed at 2.2g in baggie. This baggie was field tested, and the kit turned blue giving a positive indication for cocaine. It should be noted that during each field test, I changed my gloves and used a new sterile Q-Tip each time. Photos of the clear baggies with their weights, and positive field test kits next to each were captured on my MVR body camera, marked and labeled as evidence. In total, all three clear baggies with white substance that field tested positive for cocaine weighed at 5.6g in baggies. Photos of the yellow spoon were also captured on my MVR body camera. Additionally, I used another QuickCheck cocaine test kit on the white residue that was on the yellow</p>
