


	On Monday, March 9th, 2020 at approximately 0107 hours, Riviera Beach officers, responded to 4464 Leo LN in the City of Riviera Beach, Palm Beach County, FL in reference to a Suspicious Person.		
	Call Synopsis 911: Female (Monica Phillips) resident contacted Riviera Beach Police Department on 911 stating there was an unknown white male at her front door located at the above address. The male was kicking and beating on the front door trying to gain entry into her home. The Riviera Beach Police Communications Department notified officers they could hear the male kicking the door in the background.		
	Upon arrival Riviera Beach officers, made contact with a white male located on the front porch at the door located at 4464 Leo LN. Riviera Beach officers gave several verbal commands for the male to show his hands without incident the unknown white male was taken into custody pending further investigation. The unknown white male was later identified as Edward Preininger III (W/M, 01/28/67). Preininger III lives at 4460 Leo Ln. Preininger III was extremely intoxicated, confused, and was found to be knocking at the wrong residence. Preininger III after being placed into custody continued to insist that he lived at the victims residence. (Note: Preininger III has exhibited this same behavior in the past on at least three other occasions at the same residence prior to 03/09/2020 (4464 LEO LN).)		
The residents at 4466 LEO LN (Male and Female) stated they were awakened by the commotion at 4464 LEO LN. The two stated the following occurred not to be taken verbatim: (Refer to Sgt. T. Smith ID # 4151 BWC) Their Ring Door bell camera was activated by the incident. They hid in the home because they were extremely frightened by the incident that was occurring outside. The residents of 4466 Leo Ln stated this is not the first time that Preininger III has acted in this manner.

Phillips and husband was awakened at 0100 hours, in the morning frightened that someone was breaking into their home. Preininger III caused a loud and frightening disturbance for the neighbors of 4464 Leo LN due to his intoxicated state.

Based on the above incident Edward Preininger III was arrested for Disorderly Conduct- Disorderly Intoxication pursuant to F.S.S. 856.011. Preininger III was transported to Saint Mary's Medical Center for Medical clearance, then transported to The Riviera Beach Police Department for processing, and later to The Palm Beach County Jail.
