The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On 11/19/2019, at approximately 0040 hours, Deputy C. Rosendo (ABN 258021), responded just north of the intersection of Sheldon Rd and West Waters Ave, in reference to a single vehicle traffic crash involving a white Honda Civic (FL tag: 36GRV, VIN: 2HGFG4A54FH704165). The defendant was operating his Honda Civic and struck a curb with the driver's side tires. As a result of the crash, the Honda Civic and curb sustained a total of approximately \$3,000.00 in damages. Upon contact with the defendant, he had bloodshot glassy eyes, slurred speech, unsteady balance and the distinct odor of an alcoholic beverage was emitting from his breath as he spoke. The witness observed the defendant to be sitting in the driver's seat of the vehicle and the sole occupant. The defendant was asked to participate in the Standardized Field Sobriety Exercises, which he refused. Based on the totality, the defendant was placed under arrest for DUI with property damage. Implied consent was read and the defendant then refused to provide a lawful sample of his breath. The defendant was identified via his valid Florida driver's license.
