PERSONAL CONTACT/DRIVING PATTERN/OBSERVATIONS OF DRIVER:

On 03/07/2022 at 0054 hours I responded to an alleged hit and run involving a silver Toyota Rav 4 (FL Tag NZJL85) at 2599 Lake Ida Road.

Upon my arrival I met with, Edwin Ardilla Aguirre (Identified by NY ID), driver of a Toyota Rav 4 on the scene.

I then read Aguirre his Miranda Warnings, which he acknowledged and stated that he understood what I had read to him. Aguirre then voluntarily stated that he was driving the vehicle and he had lied about a friend's involvement because he was scared of getting into trouble due to his immigration status. I asked Aguirre if he had drank alcohol prior to driving the Toyota Rav 4 (FL Tag NZJL85) this evening and Aguirre stated that he had been drinking. Aguirre then voluntarily stated that he had drank one to two shots of Jameson liquor and two to three glasses of Astellas beer.

Aguirre elected to participate in the Field Sobriety tasks.

Below is a synopsis of the Field Sobriety tasks results:

Horizontal Gaze Nystagmus: Prior to this task Aguirre stated that he did not have any medical issues that could restrict his ability in completing this Field Sobriety task. Aguirre's left and right eyes showed a lack of smooth pursuit. Aguirre's left and right eyes were not able to hold for longer than approximately two seconds at maximum deviation.

Walk & Turn: Prior to this task Aguirre stated that he did not have any medical issues that could restrict his ability in completing this Field Sobriety task. Aguirre was unable to walk in a straight line.

One Leg Stand: Prior to this task Aguirre stated that he did not have any medical issues that could restrict his ability in completing this Field Sobriety task. Aguirre stated that he would not be able to hold his leg for a time of two minutes. I advised Aguirre that he would only be holding the position of the one leg stand for approximately thirty seconds, at which time he stated he was able to attempt the task. Aguirre was instructed to keep his arms down by his side throughout the task, he was unable to do so. Aguirre was instructed to keep his raised leg off of the ground six inches, he continually lowered his foot to the ground.

Finger to Nose: Prior to this task Aguirre stated that he did not have any medical issues that could restrict his ability in completing this Field Sobriety task. Aguirre was instructed to use his left-hand index finger to touch the tip of his nose and he attempted to use his right-hand index finger to do so.

Romberg with Recitation: Prior to this task Aguirre stated that he did not have any medical issues that could restrict his ability in completing this Field Sobriety task. I instructed Aguirre to verbally count starting from the number one and ending his count on number thirty in English, Aguirre stated he was able to complete this task. After stating the number twenty, Aguirre stated "Uh" then paused for several seconds before counting twenty-one.
