
The following incident was captured on my body worn camera.

On January 20, 2020 at approximately 10:27 PM, I was dispatched to 3700 N. Ocean Drive (Hilton Hotel) in reference to a disturbance. Upon arrival on scene, I made contact with a white female wearing a pink top, white pants, and sandals. The female was later identified as Eileen A. Hickey (D.O.B. 09/11/1946).

According to the hotel manager, Eileen was causing a disturbance and refused to leave the property, prompting the hotel staff to contact the police. It should be mentioned that Eileen was argumentative and refused to listen to me as I explained the hotel's right to refuse service. I provided Eileen with multiple opportunities to collect her belongings from her room. At first she refused, even leaving the property only to return minutes later. When Eileen finally agreed to collect her things, I escorted her to her room. Eileen again refused to collect her things and leave the property.

Eileen began screaming in the hallway prompting other guests to step out of their rooms to observe the disturbance. I then attempted to place Eileen in handcuffs and explained to Eileen that she was under arrest. Eileen yelled at me to "get away" from her and pulled her hands away from me. As I placed the handcuffs on Eileen, she then fell onto the floor and refused to stand up. Eileen had to be picked up and brought to her feet, walked to the elevators, and walked out of the hotel to my patrol vehicle. Eileen refused to enter my patrol vehicle, and had to be pulled into the vehicle.

Eileen began screaming of pain in her hip and her left shoulder. I transported Eileen to St. Mary's Medical Center for medical clearance. I later transported Eileen to the Riviera Beach Police Department for processing and later to the Palm Beach County Jail for booking. Eileen A. Hickey is being charged with one (1) count of disorderly conduct, one (1) count of resisting arrest without violence, and one (1) count of trespassing.
