- D. The Defendant waived the right to counsel at the first appearance only.

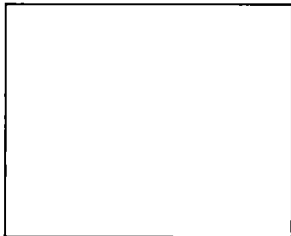
