The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a silver 2012 Nissan SUV bearing a Florida license plate of GLFY40. She was traveling east on Kennedy Blvd between S Tampania Ave and S Albany Ave and was weaving back and forth so badly she actually struck the curb a couple of times. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, droopy eyelids, extremely slurred speech, a strong odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (one drink). The defendant performed SFSEs and multiple clues of impairment were observed, in fact the defendant was so intoxicated when the instructions for the one leg stand were given to her, she started to do the walk and turn exercise again, and couldn't remember the instructions for the one leg stand. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. The defendant was identified by her FL DL.
