 The defendant was operating a white 2021 Toyota Corolla, 4 door, Florida tag NRMD76. The defendant was stopped for multiple traffic infractions. The defendant continued straight after her travel lane ended and drove through a painted safety zone. The defendant followed another vehicle too closely, and drove at speeds of 52 MPH in a properly posted 25 MPH speed limit (visually estimated and patrol car 5055 paced). The defendant was slow to react to the indication given to stop. The defendant was forgetful as related to documents requested, having needed to be reminded for two of the three requested documents. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot and watery, and her face was flushed.
