 On 06/06/2020, at approximately 0329 hours, at the intersection of Brandon Blvd and Lakewood Dr Deputy Rivera #254359 contacted the defendant on a traffic stop for failing to maintain a single lane almost hitting other vehicles. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI and refused to provide two lawful breath samples.
