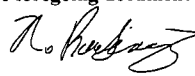

DEPUTY PALOMBO LATER REQUESTED MY ASSISTANCE BECAUSE THE DEFENDANT DID NOT SPEAK ANY ENGLISH. THEN AND THERE UNLAWFULLY DRIVE AND/OR BE IN ACTUAL PHYSICAL CONTROL OF A MOTOR VEHICLE WITHIN PINELLAS COUNTY, FLORIDA WHILE UNDER THE INFLUENCE OF AN ALCOHOLIC BEVERAGE, A CONTROLLED SUBSTANCE AND/OR ANY CHEMICAL SUBSTANCE TO THE EXTENT THAT HIS NORMAL FACULTIES WERE IMPAIRED. DEPUTY PALOMBO ATTEMPTED TO CONDUCT THE TRAFFIC STOP ON 54TH AVE N AND 58TH ST N, HOWEVER, THE DEFENDANT DISREGARD THE EMERGENCY LIGHTS AND SIRENS AND CONTINUED TO TRAVEL TOWARDS HIS HOME ADDRESS (4853 58TH S N) WHERE HE FINALLY STOPPED. DEPUTY PALOMBO MADE CONTACT WITH THE DRIVER AND BECAUSE OF THE LANGUAGE BARRIER, REQUESTED FOR MY ASSISTANCE IN ORDER TO SPEAK TO THE DEFENDANT IN SPANISH. I ARRIVED AND MADE CONTACT DEPUTY PALOMBO AND STATED THAT THE DEFENDANT WAS THE ONLY PERSON INSIDE THE CAR AT THE TIME OF THE STOP AND HE WAS THE DRIVER OF THE VEHICLE. I MADE CONTACT WITH THE DEFENDANT AND I IMMEDIATELY NOTICED SIGNS OF IMPAIRMENT, THE DEFENDANT HAD BLOOD SHOT WATERY EYES, AND DISPLAYED SLOW LETHARGIC MOVEMENTS. I ASKED THE DEFENDANT IF HE COULD PERFORM STANDARDIZED FIELD SOBRIETY EXERCISES, AND HE REFUSED. THE DEFENDANT ADMITTED TO BEEN DRINKING 2-3 BEERS POST MIRANDA WARNING. HE ALSO AGREED TO SUBMIT TO A LAWFUL TEST OF HIS BREATH. HIS FIRST SAMPLE WAS .136 AND HIS SECOND SAMPLE WAS A .145. 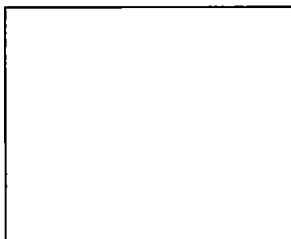
