The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did
 The defendant was observed driving a black pickup truck westbound on Kennedy Bv W from Armenia Av. The vehicle weaved in its lane and made abrupt jerky motions to stay within the lane. The vehicle continued driving in this fashion until the traffic signal at Dale Mabry Hw. The vehicle stopped too far away from the stop bar to trigger the sensor, causing it to sit through 2 cycles before changing. While waiting, the vehicle revved its engine and lurched forward before abruptly stopping. The vehicle continued westbound on Kennedy Bv W and accelerated to a speed higher than the limit, and was paced at over 55 mph in a 40 mph zone. The vehicle continued to weave in its lane and jerk abruptly. I conducted a traffic stop on the vehicle for the speeding infraction, as well as to check on the driver to ensure he was not sick, injured or impaired. The defendant exhibited indicators of impairment to include bloodshot glassy eyes, slurred speech, and the odor of an alcoholic beverage emanating from his breath. The defendant agreed to participate in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI.

The defendant provided breath samples of .220/ .227.

The defendant was ID'ed via FL DL.
