The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
On 06/04/21, at approximately 2335 hours, at [REDACTED] the defendant and the victim engaged in a verbal argument which turned physical when the defendant used her right hand and armed herself with a knife (with an approximately four inch blade) and lunged it in the direction of the victim. The victim was in fear for his life and attempted to disarm the defendant. During the physical struggle, the defendant fell into a wall and subsequently tripped and fell onto the tile floor. The victim was successful in disarming the defendant. The defendant sustained an injury to her head as a result of her own actions. The juvenile witness was present and observed this altercation.
[REDACTED] The juvenile witness, [REDACTED] identified the defendant as the person who committed this offense. The defendant verbally identified herself.
