The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 25 day of JANUARY, 2020,

at approximately 12:41 PM, at 3050 DREW ST, in Pinellas County did:

ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE TORE J. WIIK HER BOYFRIEND AND CO-HABITANT, AGAINST THE WILL OF TORE WIIK, TO-WIT: THE DEF SLAPPED THE VICTIM WITH HER RIGHT OPENED HAND. THE DEF AND VICTIM HAVE BEEN IN AN INTIMATE RELATIONSHIP FOR OVER EIGHT MONTHS AND RESIDE TOGETHER.

ON 1/25/20 AT APPROXIMATELY 1241 HRS, I WAS DISPATCHED IN RESPONSE TO A REPORT OF PARENTS BEING PHYSICAL WITH EACH OTHER IN THE PARKING LOT OF A RECREATION COMPLEX.

UPON ARRIVAL, SEVERAL WITNESSES FLAGGED ME DOWN AND ADVISED THEY OBSERVED A MALE AND FEMALE WERE FIGHTING WITH EACH OTHER IN THE PARKING LOT. THESE PARTIES EACH SEPARATELY ADVISED THE FEMALE WAS THE PRIMARY AGGRESSOR. ONE WITNESS ADVISED HE SAW THE DEF SLAP THE VICTIM. ANOTHER WITNESS STATED SHE SAW THE FEMALE NOT ALLOWING THE MALE TO WALK AWAY AND WAS WRAPPING HER HANDS AROUND THE MALE TO PREVENT HIM FROM LEAVING.

WHILE SPEAKING WITH THE VICTIM HE STATED THE DEF SLAPPED HIM ON HIS LEFT CHEEK. THE VICTIM HAD MINOR REDNESS TO HIS LEFT CHEEK AREA.

WHILE ANOTHER ON-SCENE OFFICER WAS GATHERING PERSONAL ID INFORMATION, THE DEF OPENLY STATED "YOU'RE HERE BECAUSE I SLAPPED HIM IN THE FACE." POST MIRANDA THE DEF DID NOT WISH TO SPEAK.

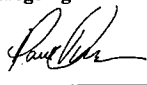

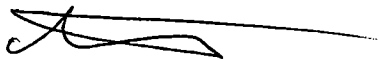
ADVISORY AND SOLVENCY HEARING

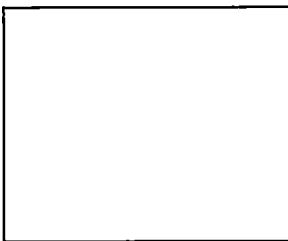
