The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:  
On 06/20/2021 at approximately Deputy Caitlyn G. Yockey ABN: 260639, Deputy Emily T. Anderson ABN: 255896 and Deputy Aaron J. Beuchel ABN: 258009 responded to 4902 Hillsborough Av E (Family Dollar parking lot ) about a single-vehicle traffic crash involving a red Toyota Corolla bearing Florida Tag: PDQK42 (HCSO: 21-409543 / DHSMV: 89446657) concerning a possible impaired driver. Deputy Emily T. Anderson advised me the traffic crash investigation by Deputy Aaron J. Beuchel ended and could start a Criminal DUI-Investigation.

I ascertained the vehicle was driven by Elvira Del Rosario Molina Correa, who was placed behind the wheel at the time of the accident; by the wheel witness, Najeel Deshaun Jones. Elvira Del Rosario Molina Correa refused EMS that arrived at the incident scene (Hillsborough Av E / 56th St N) before my arrival.

I met with Elvira Del Rosario Molina Correa, who was standing outside her vehicle. I noticed multiple signs of impairment such as red glassy eyes, slurred speech, unbalance on her feet, and a strong odor of alcoholic beverage on her breath. I asked Elvira Del Rosario Molina Correa if she was willing to perform the Standardized Field Sobriety Exercises (SFSE's). Elvira Del Rosario Molina Correa agreed to perform the SFSE's (HGN and Walk and Turn exercises) but failed to perform them as instructed and requested; see the AXON Body Cam and Roadside video footage. Due to the totality of circumstances and multiples signs of impairment observed on Elvira Del Rosario Molina Correa, I placed her under DUI arrest.

I transported Elvira Del Rosario Molina Correa to the HCSO Central Breath Testing Section. After the mandatory uninterrupted twenty-minute observation period ended, she provided two lawful breath samples. Elvira Del Rosario Molina Correa BAC reflected .150 / .147 (DUI Citation: A9IBA8E). Elvira Del Rosario Molina Correa was identified via her valid Florida DL: M-452-204-58-525-0.
