The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a silver 2009 Infinity convertible 2-door (FL TAG #DFZT18) northbound on Memorial Hwy, when she cut across several lanes of traffic (through a gore zone) and made an abrupt left turn (westbound) onto Independence Hwy. While turning, she swerved back and forth attempting to not lose control of her vehicle, leaving her lane several times and sporadically braked/accelerated. During a traffic stop for reasonable suspicion that she could be impaired, the defendant was identified via a TX DL (she also has a valid FL DL) and exhibited several clues of impairment, to include: watery/bloodshot eyes, blank/dazed stare, droopy eyelids, relaxed/lethargic appearance, fumbling fingers, admitted o drinking "2 vodka drinks" and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, she was read Implied Consent and refused to provide a breath sample.
