The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: Contact was made by Ofc D. Ziegler with the defendant as he was found stopped on the shoulder of Hillsborough Ave W, just east of Lois Ave N, passed out behind the wheel. The defendant was in actual physical control of his silver 2016 Mercedes 4-dr, bearing FL tag LEMU73. The defendant's vehicle was running. Upon making contact with the defendant, he displayed multiple signs of impairment, including: slurred speech, a strong odor of an alcoholic beverage on his breath, unsteady on his feet, and bloodshot/glassy eyes. The defendant exhibited multiple clues of impairment during the SFSEs and was arrested for DUI. The defendant later refused to complete the breath test as instructed, and insisted he was done, despite not providing two valid samples. The defendant was advised of the implied consent warning, but still refused to complete the breath test.							
The defendant identified himself via his FL driver's license.
