The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was driving a silver 2020 Jeep Wrangler (FL TAG #PZYR26) southbound on Howard Av N after pulling out of a nearby gas station, then turned westbound onto Kennedy Bl W. This section of Howard Av N is a 1-way road with northbound traffic only. During the traffic stop for driving the wrong way on a 1-way road, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, appeared tired/lethargic, and emitted a distinct odor of an alcoholic beverage from her breath. She was arrested for DUI following a poor performance on SFSEs. While at CBT, the defendant was read Implied Consent and refused to provide a breath sample.
