The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was observed driving a black Chevrolet 4D bearing FL tag NFXM47. I first observed the vehicle as it was stopped eastbound on Hillsborough Av W at the traffic signal for Rome Av N. The vehicle was stopped in a manner that its passenger side tires were on top of the lane dividing line. As the traffic signal turned green, the defendant had a delayed reaction to the light. The vehicle continued northbound on Rome Av and weaved in its lane, with its drivers side tire crossing the double yellow line multiple times. I suspected the driver to be sick, injured, or impaired and conducted a traffic stop to check the well being of the driver. Upon contact with the defendant, I observed her eyes to be glassy and her speech was slurred at times. She had an odor of an alcoholic beverage emanating from her breath as she spoke and she admitted to drinking. The defendant agreed to participate in SFSE's, however stopped and did not continue. The defendant was subsequently arrested for DUI. The defendant refused to provide a breath sample after being advised of Implied Consent. The defendant was ID'ed via passport. While searching her property in intake, a small baggie of white powder was located mixed in her belongings. It weighed approximately 1 gram and field tested positive for cocaine.
