The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:
 On 03/27/2021, at approximately 0346 hours, at the intersection of Bloomingdale Ave and Falling Oaks Dr, Deputy Castelli (ABN 259811) contacted the defendant on a traffic stop to check the well fare of the driver to see if she was ill/sick tired or impaired. Prior to Deputy Castelli conducting the traffic stop, a call for service was voiced over the radio that a white Jeep bearing FL tag HNHY79 was driving with no headlights on. Deputy Castelli observed the white Jeep hit a curb and conducted the traffic stop. The defendant emitted an odor of an alcoholic beverage from her breath, had slurred speech, bloodshot watery eyes, and she had unstable balance. Several open containers of White Claw seltzers were located in the passenger floor board. Standardized Field Sobriety Exercises were conducted and impairment was observed. Based on the totality of the investigation, the defendant was arrested for DUI. The defendant refused to provide two lawful breath samples. I advised the defendant of the Implied Consent warning in CB-02 room in CBT, where she still refused (see video). Subsequently, I completed the Affidavit Of Refusal To Submit To Breath Test. The defendant was positively identified via a Florida DL photograph.

Pursuant to Florida Statute §92.525 and under penalties of perjury, I declare that I have read the foregoing document and the facts stated in it are true to the best of my knowledge. For Notices to Appear, I also certify that a complete list of witnesses and evidence known to me is attached.
