The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/09/2020 at 0330 hours I responded to Moody Av S just south of Cleveland St W after Tampa Police Corporal Michal White's(48186) police vehicle was backed into by a white 2017 Mazda sedan as he was conducting a traffic stop on the Mazda sedan for speeding. The Mazda sedan that backed into CPL White was operated by defendant Emily Lynn Newt-Fears. Upon contact with the defendant, CPL White observed signs of impairment. Suspecting that the defendant was impaired CPL White requested a DUI unit. Upon my arrival I made contact with the defendant and immediately observed that she had bloodshot watery eyes and appeared confused. Then as I explained to her who I was and why I was there I detected a distinct odor of an alcoholic beverage. Post Miranda the defendant admitted to driving, admitted to backing into CPL White, even after seeing his emergency lights, and to also drinking "three beers, to include one canned IPA" after work that evening. She also admitted the bag of what appeared to be marijuana(3.8 grams) was marijuana. She also stated that she was going smoke the marijuana later. The defendant then exhibited additional signs of impairment during the SFSEs. At which time I placed her under arrest for DUI based upon all of my observations made thus far in my investigation. The time of arrest was 0352 hours. I then transported the defendant to the HCSO/CBT Facility where she submitted to a breath test. Her BAC was .080/.077. I identified the defendant with a Washington DL. The defendant stated that she has lived here in Florida for three months. Her vehicle still has a Washington vehicle registration. CPL White positively identified the defendant as the driver of the vehicle that struck his vehicle and he was not injured, but the damage to his police vehicle was approximately \$1000.00.
