The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was operating a white 2016 Mazda CX-9, 4 door SUV, Florida tag NGWG61. The defendant drove at a high rate of speed which nearly resulted in a collision when she nearly struck the rear of another slower moving vehicle, and she failed to come to a complete stop at a steady red traffic light when making a right turn. The defendant was stopped by TPD Officer L. Mathisen (71551), which during the stop the defendant was delayed in reacting to the stop and struck a raised curb upon coming to a stop. Officer Mathisen noted indicators of impairment to include the distinct odor of an alcoholic beverage on her breath, bloodshot and watery eyes, and slurred speech. I responded to the traffic stop location in my capacity as a DUI Investigator. The defendant had a distinct odor of an alcoholic beverage on her breath. The defendant's eyes were bloodshot, glassy, and watery. The defendant had a dazed/confused look about her face. the defendant's face was flushed, and her speech was slurred. The defendant stated she drank "two or three" shots of "green tea", which she described as being vodka type drinks. The defendant was unsteady exiting the vehicle, her gait was unsteady, and she swayed while standing. The defendant agreed to perform Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and had difficulty following simple instructions. Based on a totality of the circumstances the defendant was arrested for DUI. The defendant's behavior was cyclical and irrational with irrational thoughts and statements. The defendant had difficulty remembering information. The defendant provided breath samples of .247% BrAC and .230% BrAC. The defendant was positively identified by her Florida DL.
