The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did:

The defendant was driving a tan 2016 Subaru suv bearing a Florida license plate of ZTL40. She was traveling west on Kennedy Blvd and stopped in the number two lane (curb side lane) blocking traffic and appeared to be picking up a person that was standing on the sidewalk. The subject got into the vehicle and when the vehicle began to drive I noticed the front right tire was flat and ridding on the rim. A traffic stop was made and upon making contact with the defendant she displayed multiple indicators of impairment, to include; watery and bloodshot eyes, slurred speech, an odor of an alcoholic beverage, unsteady stance, and an admission to consuming alcohol (three beers). The defendant performed SFSEs and multiple clues of impairment were observed. The defendant was arrested for DUI and later refused to submit to a breath test, despite acknowledgment of the Implied Consent Warning. While searching the vehicle, several beer cans were located and a cup in the center console that had an odor of an alcoholic beverage.

The defendant was identified by her FL DL.
