 On listed date, time, and location, the subject was involved in a crash involving one vehicle. The driver crashed into a guardrail. Upon contact with the driver, the driver was sitting in the driver seat. The vehicle had no other occupants in the vehicle with him. The subject had blood shot, glassy eyes. The subject had slurred speech, and was unable to advise his location. The subject had a strong odor of an alcoholic beverage emitting from his breath. The subject stated he had been drinking at a Christmas party for work and stated he should not have been driving. The subject was advised the crash investigation was complete and a criminal investigation for Driving Under the Influence (DUI) was beginning. The subject then vomited outside of his vehicle. The subject exited the vehicle, and had to use the vehicle for balance. The subject was asked if he would be willing to perform Field Sobriety Exercises (FSE's). The subject fell towards the rear of my marked patrol vehicle to gain balance, to prevent from falling over. The subject was then transported off the interstate to a safer location to perform FSE's. The subject performed poorly on FSE's. Upon searching the subject, a small white powdery substance was located in the front right pocket of the subjects jeans. The subject was advised of the finding, he informed that it was cocaine and said it was also called "yayo". The subject was asked in my marked patrol vehicle if he would be willing to provide a valid breath sample to determine his blood alcohol content, in which he agreed. While inventorying the subject vehicle, a purple pipe was located in the center cup holder. The subject was then transported to Orient Road Jail without incident. This incident occurred in Hillsborough County.
