HE STOOD UP ON THE SECOND STAIR AND BOWED UP AS IF WANTING TO FIGHT. I BELIEVED MYSELF AND OFC. CONYERS WERE ABOUT TO BE ATTACKED AT THIS POINT. I RUSHED THE DEF. TO GET HIM OFF BALANCE BEFORE HE COULD CHARGE AT US. AS DEF. 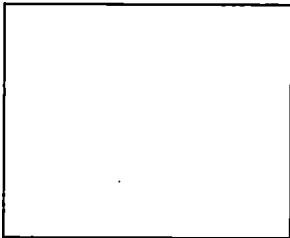
