The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 17 day of MAY, 2020,

at approximately 3:57 PM, at 4669 GULF BLVD, in Pinellas County did:

DID THEN AND THERE WILLFULLY AND MALICIOUSLY INJURE OR DAMAGE THE REAL OR PERSONAL PROPERTY OF ANOTHER, TO-WIT: TOW TRUCK "L" ARMS, THE PROPERTY OF A-1 RECOVERY BY DRIVING HIS VEHICLE OFF OF THE BACK OF THE TOW TRUCK AS THE FRONT OF THE VEHICLE WAS ENGAGED AND LIFTED BY THE "L" ARMS, DAMAGE TO SAID PROPERTY BEING \$589.72, GREATER THAN \$200 BUT LESS THAN \$1000.

TO WIT: A-1 TOWING SERVICES RESPONDED TO THIS LOCATION ON BEHALF OF THE PROPERTY OWNER TO TOW VEHICLES WHO'S OCCUPANTS PARKED IN THE BUSINESS PLAZA'S PARKING LOT WITH THE INTENTION OF GOING TO THE BEACH AND NOT PATRONIZING THE BUSINESSES IN THE PLAZA. THE VICTIM'S TOW TRUCK HOOKED UP TO A LEXUS SUV PARKED IN THE PARKING LOT FOR THE PURPOSE OF UTILIZING THE BEACH. THE TOW TRUCK REMOVED THE VEHICLE FROM ITS PARKING SPOT, RELEASED THE VEHICLE IN THE TRAFFIC WAY OF THE PARKING LOT, AND REPOSITIONED IN ORDER TO PICK UP THE VEHICLE FROM THE FRONT WHEELS. AS THE TOW TRUCK HAD IT'S "L" ARMS AROUND THE FRONT TIRES AND BEGAN TO LIFT THE VEHICLE UP FROM THE FRONT, THE DEFENDANT (WHO IS THE REGISTERED OWNER OF THE VEHICLE) ENTERED THE VEHICLE FROM THE FRONT PASSENGER SIDE. HE TURNED THE VEHICLE ON AND REVERSED OFF OF THE TOW TRUCK'S "L" ARMS. THE LEFT "L" ARM WAS BENT AS A RESULT, WITH A REPLACEMENT VALUED AT \$589.72. THE DEFENDANT FLED THE SCENE IN THE VEHICLE AND WAS LOCATED BY YOUR AFFIANT BEHIND THE PLAZA WITH THE DEFENDANT IN THE DRIVER SEAT AND ATTEMPTING TO REVERSE TO LEAVE THE AREA. THIS INCIDENT WAS CAPTURED ON VIDEO AS WELL, WHICH YOUR AFFIANT REVIEWED. NFI.

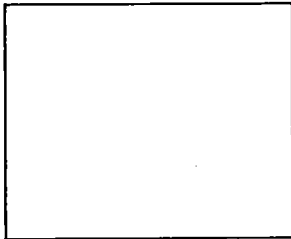
