807) north of Belvedere Road when we observed a Jupiter Police Officer in a traffic stop in the outside left turn lane to eastbound Belvedere Road. The JPD officer was participating in a DUI saturation patrol with the Palm Beach County Sheriff's Office (mutual aid agreement). I stopped behind the JPD Officer as backup. Officer Salvamini advised he stopped the silver colored Mazda for speeding. The vehicle also swerved over the solid white line that bordered the cement median. The driver then failed to stop for a great distance (see Officer Salvamini's probable cause report) Officer Salvamini advised the driver, who he identified by his Florida Driver License G643-200-90-176-0 as Eric Giraldo, with a DOB of 5/16/1990 was acting strange. Officer Salvamini requested a DUI unit to take over the traffic stop. I approached the driver and sole occupant at the driver's side door and identified myself. I asked GIRALDO if he knew why the JPD Officer stopped him. He advised for speeding. I asked GIRALDO where he was coming from and he stated from his residence at Belvedere and Jog Road. He was traveling to checkers to get food. GIRALDO had a blank stare and slight slur when he spoke. I asked him if he had consumed any alcoholic beverage and he stated no.

I asked GIRALDO to perform roadside exercise, which he agreed to do. The roadway was level, well lit and free of debris. GIRALDO was wearing sneakers. For the walk and turn exercise the solid yellow inside lane that bordered the inside left turn lane was utilized. I asked GIRALDO to step out of the vehicle. GIRALDO swayed while standing. I advised all officers on scene to turn off their front emergency and take down lights on their patrol vehicle. I asked GIRALDO if he had any medical condition and he stated he has a bad back. I asked GIRALDO if he was taking any medication and he stated he was taking muscle relaxer and was coming off an unknown respiratory medication.

During the HGN exercise GIRALDO had to be reinstructed to follow the red stimulus. I did not observe horizontal gaze nystagmus at maximum deviation, lack of smooth pursuit and onset of nystagmus prior to 45 degrees. I also did not observe vertical gaze nystagmus and lack of convergence. GIRALDO swayed while standing.

Instruction stage: GIRALDO had trouble getting into the correct starting position. I explained again left foot first and the right foot in front of his left foot. GIRALDO swayed while standing. GIRALDO started the exercise before he was told to do so. GIRALDO lost balance in the starting position. This exercise was demonstrated to GIRALDO. He stated he understood the instructions and did not have any questions.

Walk and turn stage:

GIRALDO took slow deliberate steps and didn't look at his feet while walking. At the seventh step he stopped to steady himself. GIRALDO did not take several small steps to turn around left and instead took one swing to the right to turn around. After the turn GIRALDO stepped off the line with the right foot, leaned to the right and briefly lost balance. On the sixth step he stopped to steady himself. During the whole exercise he kept his hands firm (and his elbows slightly bent) against his hip area instead of as instructed next to his body.

One leg stand:

Instruction stage:

GIRALDO left his starting position and then asked me if he could just blow in a breathalyzer. I explained to him that it was not the procedure. I asked him if he wanted to continue the exercise and he agreed to continue with the exercise. This exercise was demonstrated to GIRALDO. He stated he understood the instructions and did not have any questions.

Balancing and Counting stage:

GIRALDO raised his right foot and kept both of his knees bent. During the whole exercise GIRALDO raised his arms more than 6 inches away from his body, to maintain balance. GIRALDO did not look at his elevated foot during the whole exercise. He counted "1,2,3,4,5,6" and then started at 1 again, instead of "1001..1002" as instructed. He counted his way for 4 sets. He then placed his hands on top of his head and then waved his hands up and down. He concluded the exercise with a front kick. At the end of this exercise I asked him again if he

understood the instructions and he stated yes.

Finger to Nose:

This exercise was demonstrated to GIRALDO. He stated he understood the instructions and did not have any questions. GIRALDO indicated he did not want to close his eyes, as he was afraid he "would make the wrong move/gesture." Therefore, this exercise was not completed as instructed. The defendant used the correct hand at all times. In the beginning he had to be reinstructed to return to the starting position. Since this exercise was not performed as designed, a clear conclusion of observations could not be obtained.

Romberg balance:

Was not performed since GIRALDO would not want to close his eyes.

At 11:53 p.m., GIRALDO was placed under arrest for DUI, pursuant to F.S.S. 316.193 (1) and was transported to the Palm Beach County Jail for booking. At the county jail, a 20 min observation time was conducted. GIRALDO was then asked to provide a breath sample, which he provided. Both samples were 0.000. I then asked GIRALDO to provide a urine sample which he provided. GIRALDO was read the Miranda Warning which he understood. He then refused to answer any questions. I asked GIRALDO if he was willing to perform a drug evaluation conducted by a Drug Recognition Expert. GIRALDO first agreed, but then refused.

This incident occurred in Palm Beach County and the roadside exercise and the transport to the Palm Beach County jail was recorded via in-car camera in FHP1680.
