The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 08 day of MARCH, 2020,

at approximately 9:42 AM, at 601-3100 ROSERY RD NE, in Pinellas County did:

UNLAWFULLY OBSTRUCT OR OPPOSE SGT. VEGENSKI AND SGT. CUSUMANO DULY AND LEGALLY CONSTITUTED LAW ENFORCEMENT OFFICERS OF THE LARGO POLICE DEPARTMENT, WHILE IN THE LAWFUL EXECUTION OF A LEGAL DUTY, WHICH CONSISTED OF SECURING THE SCENE OF A BARRICADED PERSON WITH ACTIVE FELONY WARRANTS THAT WAS POSSIBLE ARMED WITH FIREARMS WITHOUT OFFERING OR DOING VIOLENCE TO THE PERSON OF THE OFFICER.

OFFICERS WERE ON SCENE OF AN ACTIVE CALL REGARDING A WANTED PERSON WHO HAD FELONY WARRANTS THAT HAD RETREATED BACK INTO HIS APARTMENT. WHILE OFFICERS ATTEMPTED TO EVACUATE NEIGHBORING UNITS FOR SAFETY AND SECURE THE SCENE, THE DEFENDANT EXITED HIS RESIDENCE NUMEROUS TIMES AND BEGAN YELLING AT OFFICERS. ON THREE SEPARATE OCCASIONS, THE SUBJECT WAS GIVEN LAWFUL ORDERS TO RETURN BACK TO HIS RESIDENCE AS HIS PRESENCE WAS DETERRING OFFICERS FROM THEIR INVESTIGATION. THE SUBJECT WAS TOLD THAT HIS FAILURE TO COMPLY WOULD RESULT IN OBSTRUCTING CHARGES AND HE CONTINUED TO REFUSE LAWFUL ORDERS. WHILE ATTEMPTING TO PLACE THE DEFENDANT INTO CUSTODY, THE DEFENDANT BRACED, TENSED AND ATTEMPTED TO GRAB A HAND RAIL IN AN ATTEMPT TO PREVENT OFFICERS FROM PLACING HIM INTO CUSTODY. THIS PROBABLE CAUSE WAS TRANSFERRED FROM SGT. CUSUMANO AND SGT. VEGENSKI.

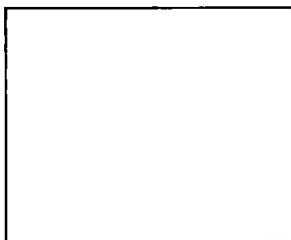
