The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was located passed out behind the wheel of his gray Mercedes 4D bearing FL tag EXJA45. The engine was running and there was condensation on the windows. A concerned citizen flagged down TPD regarding the defendant and upon officers arrival the defendant had great difficulty in rolling down his window. The defendant stated he did not have any medical conditions and stated he left the Applebee's and fell asleep in his car. The defendant exhibited indicators of impairment to include slow and uncoordinated movements, bloodshot and glassy eyes, slurred speech, the odor of an alcoholic beverage emanating from his breath, unsteadiness on his feet, and admission of drinking. The defendant participated in SFSE's which showed further indicators of impairment and was subsequently arrested for DUI. Upon search incident to arrest, the key to the vehicle was located in his front right pants pocket. The defendant provided breath samples of .153/ .155. The defendant was ID'ed via FL DL.
