 On the above listed date, time and location, Deputy Koziuk (ABN:253517) observed the defendant to be in actual physical control of a 2012 GMC Sierra (FL:708QQG) by being passed out in the driver's seat with the vehicles ignition on and the vehicle in drive. Upon contact with the defendant, indicators of impairment was observed to include bloodshot glassy eyes, slurred speech, and the odor of an alcoholic beverage emitting from his breath. The defendant refused the opportunity to perform Standardized Field Sobriety Exercises after being explained the consequences. Based on the totality of the circumstances, the defendant was arrested for DUI. The defendant refused to provide lawful breath samples after Implied Consent was read.
