On the listed date and time, at I275 N / I75 S within Hillsborough County, the affiant responded to a traffic crash call for service reference an impaired motorist. The total value of the victims property damage was approximately \$8,000 (see traffic crash report (#89442882)). The crash scene was at a location on the highway where there are no exit ramps and residences nearby, but only wood like areas. The black Chevrolet Cruze (FL Tag:QSJI93) is currently registered to the defendant, he had the electronic key fob for the vehicle in his pants pocket, and there are no other sign of involved parties reference the defendant's registered vehicle. Deputy J. Blyth #258827 made contact with the defendant and observed him to have indicators of impairment. Upon contact with the defendant, he emitted an odor of an alcoholic beverage from his breath, he had slurred speech, had bloodshot and watery eyes, and an unstable balance. Field sobriety exercises were conducted and impairment was observed. The defendant was arrested for DUI and provided two lawful breath samples after Implied Consent warning was read and understood. The first BrAC sample was .094 and the second BrAC sample was .093. The defendant was identified via a valid Florida DL.
