The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was observed to be driving a white 2017 Honda Accord (FL TAG #LGIF51) southbound on the Selmon Crosstown Expressway at a high rate of speed. His speed was confirmed by CPL M. White with LTI Laser #UX014291 to be 89 MPH. This section of the crosstown expressway is a posted 45 MPH zone and is an active construction zone; however at this time, workers were not present. During the traffic stop for the speeding infraction, the defendant took a very long time to react and stop. He was identified via a FL DL and exhibited several clues of impairment, to include: Watery/bloodshot eyes, blank/dazed stare, slurred speech, lethargic appearance, fumbling fingers, appeared confused, had poor balance, was in possession of an opened can of Truly (alcoholic water spritzer), admitted to drinking "two 14oz drafts" and taking Adderall, Zoloft & a THC Vape Pen, and had a distinct odor of an alcoholic beverage on his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he was read Implied Consent, but refused to provide a breath sample.
