The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: The defendant was operating a black 2009 Honda Civic, 2 door, Florida tag HWLE10. The defendant made a left turn U-turn against a clearly marked No U-Turn sign. A traffic stop was conducted for violation of a traffic control device. The defendant stop his vehicle so that the right side tires were on top of a painted lane marker between a left turn lane and inside through travel lane. The defendant intentionally attempted to conceal his Florida DL/ID cards in his wallet and stated he did not have his driver license in his possession when asked for his DL. The defendant was informed his DL had been observed and requested. The defendant fumbled with his wallet as he tried to retrieve the DL from it. The defendant was asked if his driver license was valid, to which he stated that it was suspended. A DHSMV computer search showed that his FL DL was suspended/revoked numerous times for refusal to submit to breath/urine/blood test, criminal fail to pay, DUI, fail to complete substance abuse course, 18 points within 18 months, and fail to appear on traffic summons. The defendant had a distinct odor of an alcoholic beverage on his breath. The defendant's eyes were bloodshot, glassy, and													
watery. The defendant's face was flushed, and his speech was slurred. The defendant stated that he drank three (3) Yuengling beers tonight at a wedding. An open, half full, refrigerated cold 16 ounce bottle of Coors Light beer was observed sitting in the upright position behind the center console of the vehicle. The defendant was unsteady exiting the vehicle, left the driver side door of the vehicle open, and swayed while standing. The defendant agreed to participate in Field Sobriety Exercises. The defendant exhibited signs and clues of impairment, and was arrested for DUI. The defendant provided breath samples of .150% and .149% BrAC. The defendant has one prior DUI conviction (8/15/16 - Flagler County, Fl.). The defendant was positively identified by his Florida ID card.
