The undersigned swears that he/she has reasonable grounds to believe that the above named defendant on the 08 day of DECEMBER, 2019,

at approximately 2:22 AM, at 12000 GULF BLVD, TREASURE ISLAND, FL 33706, in Pinellas County did:

DID THEN AND THERE ACTUALLY AND INTENTIONALLY TOUCH OR STRIKE KRZYSZTOF JEFFREY KRZYSZCZAK AGAINST THE WILL OF KRZYSZTOF JEFFREY KRZYSZCZAK, AND DID CAUSE BODILY HARM. DEF PUNCHED VICTIM IN FACE, CAUSING VICTIM TO FALL TO THE GROUND AND OBTAIN BRUISING/ABRISIONS AND LACERATIONS.

DEF AND VICTIM WERE AT A BAR IN ST. PETERSBURG WITH THEIR RESPECTIVE GIRLFRIENDS. DEF SLAPPED VICTIM'S GIRLFRIEND ON THE BUTTOCKS, CAUSING AN ARGUMENT TO ENSUE AMONG ALL PARTIES. ALL PARTIES GOT INTO AN UBER RIDESHARE AND RESPONDED TO ABOVE LOCATION AS THIS IS WHERE THEIR SHARED HOTEL WAS. AFTER ARRIVING AT THE HOTEL PROPERTY, ALL PARTIES GOT OUT OF THEIR UBER AND VICTIM STATED TO DEF "PLEASE DON'T DISRESPECT SARAH AGAIN." DEF IN TURN PUNCHED VICTIM IN THE FACE TWICE WITH A CLOSED RIGHT FIST, AND THEN A CLOSED LEFT FIST CAUSING VICTIM TO FALL TO THE GROUND. VICTIM HIT HIS FACE ON THE PAVEMENT CAUSING A LACERATION, BLEEDING AND ABRASIONS TO THE RIGHT SIDE OF THE FACE AND A HEMATOMA TO THE FOREHEAD AREA. WHEN ASKED WHAT HAPPENED DEF ADVISED HE PUNCHED VICTIM IN SELF DEFENSE ADVISING DEF WAS "APPROACHING HIM AGGRESSIVELY." POST MIRANDA, DEF ADMITTED TO SLAPPING DEF'S GIRLFRIEND ON THE BUTTOCKS AND MAINTAINED HE WAS ACTING IN SELF DEFENSE.

DEF HAS NO LOCAL TIES TO THE AREA, THEREFORE HE IS NOT APAD ELIGIBLE.

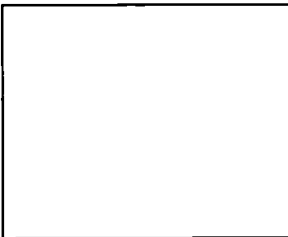
