The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On May 25, 2020, at 2036 hours, Deputy Frankowski #260035, responded to a suspicious person call. Deputy Frankowski came in contact with the defendant who was in a blue Pontiac bearing Florida tag #3281QJ. Deputy Frankowski observed the defendant to have slurred speech, speaking incoherent, unable to keep balance, and was in the driver seat with his keys in his right hand. While being detained for the purposes of driving under the influence investigation the defendant fled on foot. Deputy Frankowski caught the defendant. The defendant was brought to Central Breath Testing where he performed standardized field sobriety exercises. During the exercises, the defendant showed multiple signs of impairment and was subsequently arrested for DUI. After a proper 20 minute observation period was conducted, the defendant provided two lawful breath samples of 0.199%BrAC/0.196%BrAC. I issued the defendant DUI citation #A851N3E, which reflects the DUI charge. The defendant was identified via his Florida Driver's License.
