 The defendant was stopped for running a stop sign at 15th St N and Adamo Dr. The defendant was driving her 2016 Nissan Murano, bearing FL tag #J29EM. Upon making contact with the defendant, she displayed multiple indicators of impairment, including: bloodshot/glassy eyes, a strong odor of an alcoholic beverage on her breath, club wristband on her left wrist, fumbling with her phone while attempting to locate her proof of insurance, and swaying as she stood. The defendant exhibited multiple clues of impairment during the SFSEs and was arrested for DUI. The defendant later submitted to the breath test, which had a BrAC of .187/.188.

The defendant identified herself via her FL driver's license.
