at approximately 12:33 AM, at US HIGHWAY 19 N & ENTERPRISE RD, in Pinellas County did:

REASON FOR STOP:

THE DEF WAS OBSERVED IN ACTUAL PHYSICAL CONTROL OF HIS VEHICLE WHEN HE WAS OBSERVED BY OFFICER MILLER TO BE TRAVELING NORTH BOUND AT AN ELEVATED SPEED. OFFICER MILLER WAS ABLE TO CAPTURE THE SPEED OF THE DEF TO BE 74 MPH IN A 55-MPH ZONE. OFFICER MILLER INITIATED A TRAFFIC STOP A OBSERVED SEVERAL SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY GLASSY EYES, SLURRED SPEECH AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AND PERSON. THIS OFFICER ARRIVED ON SCENE AND OBSERVED THE SAME SIGNS OF IMPAIRMENT TO INCLUDE BLOODSHOT WATERY/GLASSY EYES, SLURRED SPEECH, SWAYING BACK AND FORTH, BODY AND EYE LID TREMORS, AND THE STRONG ODOR OF AN ALCOHOLIC BEVERAGE COMING FROM HIS BREATH AND PERSON. THE DEF PARTICIPATED IN ALL SFST AND PERFORMED POORLY ON ALL SFST. THE DEF THEN PROVIDED A SAMPLE OF HIS BREATH SHOWING HIS BRAC TO BE 0.161 AND 0.155.

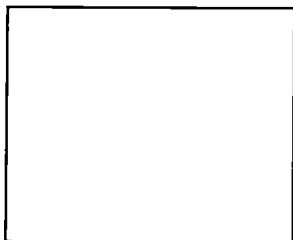
