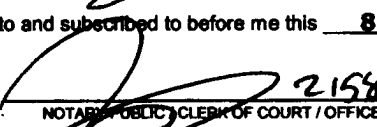

N A R A T I V E

Ofc. Abreu advised that the caller white female Gomez, Fany Sarai (08/27/1994) and white male Fernandez, Erick (06/01/1986) have been dating for four years, have been living in the same residence for approximately four years and have no children in common. She advised to Ofc. Aberu that she and Erick have had a verbal dispute about infidelity. While they were having their argument, Erick began destroying property in the residence which led her to take phone and threatened to call 911. When she had the phone in her hand, he struck her on the top left area of her head with his hand and took her phone and placed the phone on a table so she couldn't call 911. Once she was hit, she took her phone from the table and called 911. Erick then struck her again on the same area of her head with his hand.

Ofc. McDonald examined Fany's head and felt a lump on the top left side of her head that was consistent with Fany stating where she was struck by Erick's hand.

Post Miranda Eric stated that he had a verbal altercation with Fany. He stated that in the duration of their verbal altercation he pushed her out of the his way and not other physcial altercation occurred from there on. He stated that she called 911 after he pushed her out of his way.

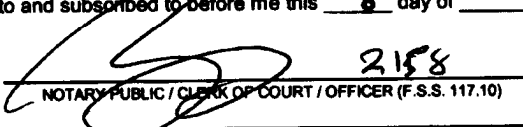
Based on the above facts there was probable cause that existed to charge Erick for violating F.S.S 784.03 (1A1)DC.
