The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: I observed the defendant driving a gray Toyota Scion with FL tag LNF129 on N. Dale Mabry Hwy. She swerved out of her lane. When she continued forward she weaved side to side. She varied her speed and was speeding 55 mph in a 45 mph zone. at a red light she stopped completely past the stop bar into the marked pedestrian walkway and continued inching forward while the light was still red. I conducted a traffic stop and made contact with the defendant who was in the driver's seat and only occupant of the vehicle. Upon contact I could smell the odor of alcoholic beverages coming from her breath. Her eyes were red and glassy. She said she had been drinking alcohol. She performed field sobriety exercises and showed impairment. Post arrest I advised her of implied consent and she understood and refused to provide a breath sample. Defendant ID'd by FL DL.
