The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did: On the above date and time the affiant conducted a traffic stop on a 2013 silver VW sedan bearing PA-tag (FVS1197) in reference to exceeding the posted speed limit and improper left turn. Upon contact with the defendant who was the sole occupant of the vehicle I detected signs of impairment. The defendant was then asked to participate in field sobriety exercises which she agreed to perform. During the exercises the defendant fail to follow instructions provided and fully cooperate. Due to the signs of impairment observed and the totality of the circumstances the defendant was placed under arrest for DUI. The defendant was then transported to CBT and asked to provide two lawful breath sample which she agreed to provide. After a proper 20 minute observation the defendant fail to give a breath sample after three attempt and the machine timed out on all three occasions. Due to the defendant being uncooperative the defendant could not be given their implied consent warning. The defendants identity was verified via Florida DL (P362212887030).
