Before me this date personally appeared BLACK GORDON (16032) who being first duly sworn deposes and says that on _____ day of _____, (year) _____ at 600 N POWERLINE RD DEERFIELD BEACH, FL 33442 (crime location) the above named defendant committed the above offenses charged and the facts showing probable cause to believe the same are as follows

involved in the accident W/F Erin Elhem (08/01/1967) and as I began to speak with Elhen I could immediately smell an odor of an alcoholic beverage on her breath Elhen advised she was driving north on N Powerline Rd and the driver of the Mercedes Benz crashed into her I then spoke Deputy Gorel again who advised he spoke with the witness Mathew Hoseman who stated Elhan was driving south and turned into the path of the Mercedes driven by W/F Andrea Kattoura I then made contact with Kattoura who advised she was traveling north on N Powerline Rd and as she approached NW 6th St the other involved vehicle turned in her path Kattoura stated she had the right of way and the green light

I again went over to Henna and advised he there was a witness to the accident and the witness stated she was the driver who caused the accident Elhen again stated she was not the at fault driver and I again could smell the alcohol on her breath Elhan also had glassy blood shot eyes and when I asked her where she was coming from she pointed south and stated she was going to 18th street which is north I asked Elhan if she had anything to drink and she stated she did have a couple of drinks earlier at the beach.

After speaking with deputies I asked Ehlen to do the Standardized Field Sobriety Exercises at which time she complied. I conducted a Horizontal Gaze Nystagmus (HGN) at which time she had a lack of smooth pursuit in both eyes and I had to tell Elhen to keep her head straight on numerous occasions. I then asked Ehlen to do the Walk and Turn at which time as she did the exercises she lost her balance and swayed back and forth and at on point she began to dance

I then asked Ehlen to conduct the finger to nose exercise at which time she touched
