I again went over to Henna and advised he there was a witness to the accident 3hd the witness stated she was the driver who caused the accident Elhen again stated she was not the at fault driver and I again could smell the alcohol on her breath. Elhan akso had glassy blood shot eyes and when I asked her where she was coming from she pinted south and stated she was going to 18th street which is north I asked Elhan if she had anything to drink and she stated she did have a couple of drinks earlier at the beach.

After speaking with deputies I asked Ehlen to do the Standardized Field Sobriety Exercises at which time she complied. I conducted a Horizontal Gaze Nystagmus (HGN) at which time she had a lack of smooth pursuit in both eyes and I had to tell Elhen to keep her head straight on numerous occasions. I then asked Ehlen to do the Walk and Turn at which time as she did the exercises she lost her balance and swayed back and forth and at on point she began to dance
