The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did On 11/14/2020 at approximately 0227 hours, a traffic stop was conducted on a silver 2003 BMW coupe with Florida tag NNIQ38 at the intersection of Sligh Av E and Willow Av N after the vehicle was observed speeding (51/35 MPH) and failing to maintain a single travel lane.
