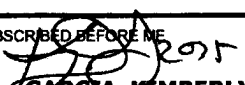

N O T A R Y P U B L I C	On Monday, March 14, 2022, members of the Special Investigation Division were conducting a prostitution operation within the North end of the City. It should be noted there have been numerous complaints regarding this issue from concerned citizens. The operation involved officers working in an undercover capacity and was intended to curb prostitution activity within the City. At approximately 1835 hours the defendant, now known Errol Ingram (black male, 11/23/1953) made contact with UC Officer Gadson, who was working in an undercover capacity near the intersection of Butler St. and N Dixie Hwy, West Palm Beach. The defendant arrived in the area in a silver Nissan Murano, bearing Florida tag NXYJ25. The defendant made contact with UC Gadson and advised he wanted to have sexual intercourse. The defendant agreed to pay the UC \$25.00 for sexual intercourse. After the defendant solicited the undercover officer for sex acts in exchange for money, uniformed officers conducted a traffic stop on the vehicle and took the offender into custody in the area of 1705 N Dixie Hwy. without incident. The conversation between the defendant and the undercover officer was audio recorded for evidentiary purposes. Due to the facts stated above, probable cause exists to charge Errol Ingram for one (1) count Prostitution (Solicit another), per F.S.S. 796.07 (2E).
