The undersigned swears there are reasonable grounds to believe that the above named defendant in Hillsborough County, Florida, did The defendant was driving a silver 2016 VolksWagon Jetta (FL TAG #NJSP60) eastbound on Cleveland St W, head-on towards me. This section of Cleveland St W is a 1-way street with westbound traffic only. During the traffic stop for driving the wrong way, the defendant was identified via a FL DL and exhibited several clues of impairment, to include: watery/bloodshot eyes, slurred speech, confusion/disorientation, was wearing a blue paper nightclub wristband, and emitted a distinct odor of an alcoholic beverage from his breath. He was arrested for DUI following a poor performance on SFSEs. While at CBT, he stated that he would willingly provided a breath sample; however changed his mind after the 20 minute observation period. He was read Implied Consent and refused again to provide a breath sample.
